A typical sanctuary worship service follows the RCA order of worship. We use the common lectionary. The worship service is a structured liturgy based on three parts; approach to God, Word of God, and response to God. The drive-in worship service is less formal, but would not be described as contemporary or alternative. The drive-in service is a shorter version of the sanctuary service. First Church has a fine pipe organ which is used in most sanctuary services. Occasionally music is provided by other instruments and by a local jazz trio.

Capital Campaign in 2010-2012 raised \$450,000 for major building repairs and special ministries whose cost was apx. \$2,300,000. Remaining funds were borrowed from a loan management account maintained by our investment advisor and secured by the main endowment fund. Since then the overall growth in the endowment fund (market increases, interest, dividends) has exceeded the interest rate on the loan.

### What is the stated mission, vision, or purpose of your congregation?

The First Church in Albany includes young and old, families, couples and singles, rich and poor, persons of various races, ethnicities, backgrounds, sexual orientation and gender identities, differing physical and mental abilities, believers and seekers. We welcome into the full life of the church all those whom God sends us. Centered in Christ, we commit ourselves to breaking down dividing walls and building a community where all are loved.

# What specific ministry goals have been developed from your mission and vision statement for the next five years?

Worship is the central expression of our ministry to our congregation and to those from the community who may join us. Members and friends of First Church want to broaden our current approaches in two areas of the worship experience. Our goal is to satisfy diverse tastes and increase congregants' comfort level with the service. This may be accomplished by utilizing various styles of worship and providing for more involvement of congregation members as worship leaders (readers of prayers, liturgies, and litanies, even messages). Responsive reading encourages participation and requires focus. Guest preachers offer diversity of style and message. An effort should be made to convey the full biblical message by using the entire lectionary as a basis for worship and sermons (including Old Testament lessons). Series of sermons developing one topic (e.g. Creation) have been successful. Variety in worship music, including alternative instruments (guitar, piano, percussion, brass, strings) and alternative vocal music (spirituals, world music), has been well received. Congregants admire First Church's great pipe organ and value the contributions of our music program.

# What new program or outreach ministry expansion do you hope to provide in the next five years? Include long-range or strategic plan.

First Church currently does not have a long-range or strategic plan, we are looking forward to working with our new pastor in developing a long range/strategic plan for our congregation. Members of First Church have many ideas for congregational activities and community outreach. These ideas are partly an extension of current programs, while others are an expansion of outreach ministries. They include providing a bus or van to transport people to/from church; educational programming such as speakers and lectures; Bible study for more people, especially for youth; and classes in parenting and other family needs. Social activities such as church outings in and around Albany (movies, plays, even cruises) have been suggested. Our current outreach activities (mission trips for youth, food pantry) could be expanded. (Suggestions include a small shelter for homeless women and families, soup kitchen two times a week, a thrift shop, and a ministry to offenders and ex-offenders). Re-establishing the Community Outreach Commission would help implement such proposals.

### What leadership roles do women currently fill in your church?

Senior Minister (interim), Minister of Discipleship, Minister of Music, leaders of Children and Worship program, Elders, Deacons, Trustees. Women serve as Parish Administrator, Accounts Manager, Communications Coordinator, Food Pantry Coordinator, child care aides, and youth advisors

### Children and youth programs/organizations (briefly describe; include age range of each).

**Children and Worship:** This program began five years ago. It is a worship time of 45 minutes each Sunday when children go to their own worship center, immediately after the children's sermon in the sanctuary worship service. In the worship center they hear/see biblical stories, do artwork for expression, and have prayers and songs. This program has replaced Sunday school. This past year we had up to six children attending 4-7 year worship and two or three older children attending 8-12 year worship. This latter program began three years ago and attendance has been steady. In the younger program there has been a slight increase in attendance.

**Youth Group/Young Adults:** Young people aged 13-30 meet four times a year to do mission work in the community or go on special, church-funded mission trips out–of-state.

## Adult Education and Activities (describe briefly)

**Adult Bible Study:** Open group of about eight adults meets each Tuesday to study the Bible and share conversation about their faith. This group has also studied the Muslim faith and explored the biblical basis of our RCA doctrines. There are a few members in Bible study who come from outside the congregation.

**Non-Violent Communication Workshops and Practice Groups:** Workshops have been offered at First Church, the FOCUS churches (with which First Church is associated), and Albany Medical Center (chaplaincy trainings). There have been monthly practice groups with five to eleven participants. These groups were active for five years and were most recently led by Pete Pagerey and Robin Hepko. Participants were from both the community and the First Church congregation.

**Pilgrim's Walk:** For those in the third stage of life (ages 65 to end of life). This was offered at First Church four years ago and since 2013 out in community, at the Beltrone and Beverwyck senior living communities. Average group size is eight to fifteen participants. Problems of aging, transition from home to independent or assisted living, relationships and loss, employment to retirement, are some of the discussion topics. Death and dying, purpose, coping, leisure, and spiritual development are other leading topics. Pilgrim's Walk is currently offered at the Beverwyck and led by Cheryl Gowie; twelve participants.

**Prayer Shawl Ministry:** There are eight participants who meet monthly to make prayer shawls for those in need both within First Church and out in the greater community. Shawls are blessed in worship and given by members to those for whom we care.

**Congregational Care Callers:** Several members of the congregation assist the ministers in visits to those who are homebound and unable to come to worship services and other events.

**Journey through the Psalms:** A current Bible study program offered after worship. Participants learn about the healing nature of the Psalms and their relationship to our faith journeys. This program began in September 2018 and continues through Advent.

**Membership Class for Adults:** A small–group program is available for those adults who are considering membership in First Church. It is offered as need arises.

**Confirmation Class:** Teenagers attend three months of classes with the Senior Minister and Minister of Discipleship, exploring God's Word and declaring their personal faith publicly, with support of their mentors. The class is offered as need arises.

**Weathervanes:** A group for older adults meets for luncheon and a program once a month except during the summer. (The "Weathervanes" are named for the historic brass weathervane that stood on top of the 1656 and 1715 churches and is now on display at First Church.)

**FOCUS Churches:** The FOCUS congregations are six covenant churches (First Church in Albany, Westminster Presbyterian Church, Trinity United Methodist Church, Emmanuel Baptist Church, Delmar Reformed Church, and First Presbyterian Church), four faith affiliates, and two faith partners.

**FOCUS Churches Mission:** Doing together what we cannot do alone, united in a common calling to respond to our neighbors' needs in the city of Albany and beyond, as God's servant people in a broken and hurting world, FOCUS now serves hungry bodies and souls through its feeding programs. The Breakfast Club at Westminster Presbyterian Church provides more than 18,000 meals year-round and helps connect guests with much-needed services such as housing. The Interfaith Food Pantry located at Emmanuel Baptist Church and the affiliated Food Pantry at First Church in Albany offer food supplies to families and individuals in need. And with each meal FOCUS serves a helping of hospitality. FOCUS also gives voice to critical issues of hunger and homelessness and joins with other organizations to raise awareness of the impacts and needs of those living in poverty.

**First Church Food Pantry:** Operating continuously since 1980, the First Church Food Pantry serves disadvantaged households (families and single persons) in the lower Clinton Avenue neighborhood of Albany. The Food Pantry is staffed by volunteers and managed by a part-time coordinator. The Pantry is open two mornings each week. In a recent month the Food Pantry served 215 individuals, each person receiving food for eighteen meals. Food Pantry clients are welcome to attend our worship services, and some do.

Emergency Overflow Shelter Meals: Since 2008 First Church members have been providing dinner at the Shelter two Fridays a month, from November through April. The Emergency Overflow Shelter is a "shelter of last resort" year-round when other shelters are full. It also serves those who are not eligible for other shelters because of addictions or mental health problems. Located at First Lutheran Church in Albany, it is open during the winter months and attempts to turn nobody away. About thirty people have contributed food and delivered meals to the shelter.

**First Church Readers**: First Church Readers is a small group of six people who meet to discuss a wide change of fiction and non-fiction books. The group meets once a month in the post-service hour to discuss a book read in the past month.

**First Church Choir:** Thirteen people, including two paid soloists, make up the choir at First Church. The choir is an essential part of our weekly worship service, September through June. Choir members frequently provide music at drive-in services during the summer. The choir is supplemented on special occasions by instrumentalists (such as brass, strings, and a local jazz trio).

Describe one event or experience over the last year that has significantly contributed to the spiritual life of the congregation.

Transition Team activities from fall 2017 through spring 2018 involved a large part of the congregation. "Cottage Meetings" were well-attended and helped us know each other better. Those meetings and other gatherings were well-structured to elicit comments about our current situation and hopes for the future of our church.

### **BUILDING INFORMATION**

First Church's current sanctuary was built in 1796-97 and is a National Historic Landmark. The parish house, built in 1938, and expanded in 1988 with elevator access, is a three-story building attached to church. It includes a spacious lobby, offices, classrooms, meeting rooms (including Zimmerman Hall on the ground level), choir room, gymnasium, and facilities for our food pantry.

### Membership: What method is used in selecting members?

Members of Consistory are nominated at-large by the congregation. The consistory votes on candidates from the nominee list. Deacons and Elders serve a two-year term and are generally expected to serve two terms (four years). There is a mandatory year-off after four years. There is a separate Board of Trustees, responsible for church facilities and financial assets. Trustees serve three-year terms; there is no limit on number of terms served. The responsibilities of the Board of Trustees are set by New York state law and by First Church by-laws.

Members of Consistory and Board of Trustees are elected by members of First Church at the annual congregational meeting in May. We ask for the congregation's prayerful consideration of people whom they think might be gifted and called to serve as our leaders.

The Consistory (boards of Elders and Deacons) meets monthly. The Consistory and the Board of Trustees meet as the "Joint Boards" to approve the annual church budget and to extend a call to a minister. The Senior Elder, Assistant Senior Elder, Senior Deacon, Assistant Senior Deacon, and the President and Vice-President of the Board of Trustees with the Senior Minister form the Leadership Committee. That committee acts as a personnel committee, compiles the annual budget (with input from others) for approval by the Joint Boards, approves building use requests, and advises the Senior Minister, especially between stated meetings of Consistory and the Board of Trustees.

Elders are set apart for a ministry of watchful and responsible care for the welfare and order of the church. They have oversight of all members, including one another, the deacons, and the ministers, equipping everyone to live in harmony with God's Word. At their ordination elders are asked: "Will you faithfully, diligently, and cheerfully study God's Word, oversee the household of faith, encourage spiritual growth, maintain loving discipline?" (From RCA Book of Church

Order) In First Church the Elders help serve communion, assist in home visitation, oversee the spiritual welfare of the congregation, and maintain the membership rolls.

Deacons are set apart for a ministry of mercy, service, and outreach. At their ordination deacons are asked: "Will you faithfully, diligently, and cheerfully manifest Christ's love and care, gather and distribute the offerings of God's people, visit and comfort the distressed, minister to the poor and needy, and strive to advance God's reign of justice and peace?" (From RCA Book of Church Order) In First Church the Deacons help serve communion, are responsible for ushering at Sunday and special services, develop the budget for benevolences, and administer the Deacons' Fund for special assistance to needy individuals.

**Trustees** are responsible for the building, property, and financial management of First Church. They make decisions concerning the church's endowment fund, capital improvements, two parking lots (one of them leased), Clee Park, and building maintenance. Trustees also are responsible for non-ministerial staff. The Board of Trustees meets four times a year with additional meetings as needed.

Leaders, members, and staff of First Church are aware of changes, progress, and problems in our city and region. We devote attention and resources to those issues where we think we can make a difference. First Church is providing increased volunteer and financial resources to our food pantry, and recently obtained two grants to cover part of the cost of food. The church has hosted public meetings concerning the proposed power facility. First Church tries to make its worship services a comfortable experience for the unchurched while retaining the Reformed liturgy. Our church facilities are made available for occasional ecumenical and community events.

Armenian Orthodox, Roman Catholic, American Baptist, Buddhist, Episcopal, Greek Orthodox, Hinduism, Islam, Jewish, Evangelical Lutheran, Lutheran (Missouri Synod), Presbyterian, United Methodist, Pentecostal, Unitarian-Universalist, United Church of Christ, and others. Roman Catholics comprise about two-thirds of the population of the Capital District that is affiliated with a religious group, according to a newspaper report a few years ago.

# Outreach: What percentage of the people who live within a mile of your church are unchurched, and what is your strategy to reach unchurched people in your community?

Percentage is unknown. Anyone is welcome to attend worship services at First Church, and to participate in programs and activities. The "community" from which First Church draws its members is the entire Capital District. Our congregation is more a "destination congregation" than a "neighborhood church." ### Describe your community and school system:

Albany is the capital of New York State, conveniently located near New York City, Boston, Saratoga Springs, Montreal, and New York's Adirondack Park. Albany has long been a center of government, finance, higher education, and transportation. Over the past few decades the Capital District has become prominent in high-technology research, development, and manufacturing (computer chips, pharmaceuticals).

Albany is a community of over 98,000 people. Albany combined with the cities of Troy and Schenectady and surrounding suburbs comprise the Capital District, with a population of approximately 881,830. There are multiple colleges and universities in the area including SUNY University at Albany, SUNY College of Nanoscale Science and Engineering, Empire State College (distance learning), Hudson Valley Community College, Siena College, College of St. Rose, Russell Sage College, Schenectady Community College, Skidmore College, Rensselaer Polytechnic Institute, Sage Colleges, and Union College, which includes schools of medicine, law, and pharmacy.

The Albany City School District has 18 schools including 12 elementary, three middle schools, and one comprehensive high school, serving a student body of 9,500. Most of Albany's 12 elementary schools are neighborhood schools with an open enrollment policy. Three are magnet schools with specialized curricula. All elementary schools offer full-day pre-kindergarten and most offer full-day kindergarten.

Albany High School features four themed academies, the prestigious International Baccalaureate program, and one of the largest selections of Advanced Placement courses offered in the Capital Region. At the elementary level, the district offers full-day prekindergarten at every school and at several community locations, and outstanding school-choice options that include three theme-based magnet elementary schools, the Dual Language Program and open enrollment options across the district.

The profile is the key document that will inform prospective candidates of who we are as a congregation, and what we do in worship, congregational life, and outreach ministries. The profile will state what talents and gifts in a senior minister will help lead us into the future filled with faith, hope, and love.

The church profile follows the format provided by the Reformed Church in America, and it will be a long document. It will include general information about First Church--our membership, leadership, and employees; our worship, education, and ministry; our physical facilities and financial situation; and also about the larger community of which we are a part. The profile states our expectations and requirements of a senior minister and the projected salary range and benefits package.

Most of the profile is now drafted, compiled by the search committee working together, and drawing very much on data assembled by the transition team in "cottage meetings" and other occasions. We expect that the church profile will be ready to share with the joint boards for information, comment, revision, and approval by mid-October. The profile will then be formatted with pictures and be ready to send to the RCA within weeks after that.

The search committee appreciates the interest many in the congregation have expressed in our activities. We welcome questions about our responsibilities and process, and we will continue to keep the First Church family informed.

#### JOINT BOARDS RETREAT

On September 22, eleven members of the Joint Boards, both pastors and one of our Classis supervisors gathered for a retreat at Delmar Reformed Church. The purpose of the retreat was:

- 1. To engage our joint work on God's behalf at First Church
- 2. To foster community among us for this next year of the transition
- 3. To explore together one of our transitional goals:

Does our current governance structure help us fulfill our mission?

- Does the wider congregation, especially newcomers, understand how things work?
- Do those who accept roles have meaningful work to do?
- Are we right-sized for the current congregation?

The Rev. David Jones, pastor of Greenbush Reformed Church, led us in an opening devotion. The group then spent time in group building exercises before delving into developing a common understanding of First Church's governance structure. We shared current perceptions, heard from Jim Folts about the way the structure is intended to work, as well as about religious corporation law, and from Pete Pagerey about how the Book of Church Order defines RCA church governance and how most other RCA churches work. Lynn Carman Bodden gave her take on the impact of the history behind our current Trustee Board and the Joint Boards. There was honest sharing about what works well and what has created some friction in the past.

After a tasty lunch, the group wrestled with how we want to function practically, looking at power dynamics, clarity of roles (Trustees, Consistory, Elders, Deacons, Joint Boards, pastors), communication, and the matching of gifts of members to the needs of the church. Several short-term goals were surfaced and responsibility for follow-up assigned. More on these later!

The Joint Boards will meet next to approve next year's budget as well as the church profile. Consistory will meet on October 3, and Trustees at the end of October.

- November Code Girls: The Untold Story of the American Women Code Breakers of World War II Liza Mundy. More than 10,000 girls were recruited to do the secret work of breaking codes in WW II. Their work was forgotten and their sacrifices were unsung until this highly readable, well researched and documented story.

- American Jezebel: The Uncommon Life of Anne Hutchinson, the Woman Who Defied the Puritans by Eve Laplante. In her new book she explores darkness and why light is associated with goodness and darkness with evil "teaching us how to find our footing in times of uncertainty and giving us strength and hope to face all of life's challenging moments."




#### **CHRISTMAS PAGEANT**

The Emergency Overflow Shelter at First Lutheran Church in Albany, sponsored by the Capital Area Council of Churches, is a "shelter of last resort" when other shelters are full or for those not be eligible for other shelters because of addictions or mental health issues. It is open during the winter months and turns nobody away.

#### FIRST CHURCH FACILITIES ARE USED AND AVAILABLE FOR USE

First Church has a large facility with various spaces that are convenient for groups of various sizes, with ample parking and a convenient location in downtown Albany. Each year several groups receive permission to use our facility. Such requests are approved by the Building Use Committee, composed of members of Leadership and the Treasurer. First Church charges fees to cover out-of-pocket expenses, though the fees are waived for an RCA or FOCUS-related event. A higher fee schedule applies to for-profit organizations. In addition, tours are offered to groups that are interested in First Church's history and architecture. And many individual visitors from places near and far come to First Church unscheduled, and are welcome to take a self-guided tour of our historic sanctuary.
